### AMENDED ARTICLES OF INCORPORATION

OF

## CENTER FOR AGRICULTURE AND RURAL DEVELOPMENT (CARD) MUTUAL BENEFIT ASSOCIATION, INC.

Name of Corporation

#### KNOW ALL MEN BY THESE PRESENTS:

That we, all of legal age, citizens and residents of the Republic of the Philippines, have this day voluntarily associated ourselves together for the purpose of forming a non-stock, non-profit association under the laws of the Republic of the Philippines.

#### AND WE HEREBY CERTIFY:

FIRST: That the name of the said corporation shall be:

### CENTER FOR AGRICULTURE AND RURAL DEVELOPMENT (CARD) MUTUAL BENEFIT ASSOCIATION, INC.

SECOND: That the purposes for which the said corporation is formed are:

- To promote the welfare of marginalized sectors of Philippine society and to other sectors as maybe determined by the board;
- 2. To extend financial assistance to its members in the form of death benefits, medical subsidy, pension and loan redemption assistance;
- 3. To ensure continued access to benefits/resources by actively involving the members in the direct management of the association that will include implementation of policies and procedures geared towards sustainability and improved services.
- 4. To adopt a prudent cash management program to invest all cash in excess of current disbursement through a majority vote of its Board of Trustees. (As Amended on July 3, 2018)

**THIRD**: That the place where the principal office of the corporation is to be established or located is at 120 M. Paulino St. corner Burgos St., Brgy. VII-D, San Pablo City, Laguna, Philippines. (As Amended on September 5, 2016)

**FOURTH :** That the term for which said corporation is to exist is fifty (50) years from and after date of incorporation

**EIGHT**: That no part of income which the corporation may obtain as an incident to its operation shall be distributed as dividends to its members, trustees or officers subject to the provisions of the Corporation Code on dissolution and any profits obtained as a result of its operation, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provisions of Title XI of the Corporation Code of the Philippines.

#### NINTH: In case of dissolution:

1. Assets of the association shall be transferred to similar institution;

2. Residual assets after the liabilities and obligations are settled and paid shall be transferred to mother MFI, or by 2/3 vote of all its members to another corporation of similar or related purpose;

3. All creditors shall be paid; assets held subject to return on dissolution shall be delivered back to their givers; assets transferred to another accredited NGO/s or

organization/s of similar purpose.

4. Assets shall be distributed to one or more entities formed for the purpose/s similar

to its own;

 Assets distributed to another accredited NGO/s or Association/s organized for similar purpose; shall be distributed by a competent court of justice to another accredited NGO/s or Association/s. (As Amended on July 3, 2018)

**TENTH**: That CRESENCIA M. BRUCAL has been elected by the members as Treasurer of the Association to act as such until her successor is duly elected and qualified in accordance with the by-laws, and that as such Treasurer she has been authorized to receive for the benefit of the association all contributions or donations paid or given by the members.

**ELEVENTH** : That the corporation manifests its willingness to change its corporate name in the event another person, firm or entity has acquired a prior right to use the said firm name or one deceptively or confusingly similar to it.

TWELFTH: That the Members of the Board of Trustees shall not receive any compensation or fixed remuneration in the exercise of their functions

THIRTEENTH: That the corporation shall comply with the rules and regulations of the Securities and Exchange Commission for non-stock corporations in the course of its operation.
